Has been inspected under the national inspection programme in connection with Manufacturing Authorisation no. **SAM0015** in accordance with Good Manufacturing Practice (GMP) and the following national legislation:

From the knowledge gained during inspection of this manufacturer, the latest of which was conducted on **29th – 30th June 2023**, it is considered that it does not comply with the principles and guidelines of Good Manufacturing Practice as required by the Veterinary Medicines Regulations 2013.

This non-compliance statement reflects the status of the manufacturing site at the time of the inspection noted above. As this is a second non-compliance statement issued, the company is required to cease manufacture of the Exemptions for Small Pet Animals' (ESPA) products. The company's SAM authorisation will be suspended for 12 months but may be reinstated if a further inspection within that period demonstrates that the company is compliant with GMP.
